The above fees are flat-rate amounts and already take into account holiday periods and absences due to illness.

Household income is not requested prior to the conclusion of a school contract and is not relevant for admission.

The following services are included in the school fees:

- Primary Level: Breakfast, morning snack, and all-day provision of fruit/vegetables and beverages (tea/water), Lunch is funded by the Berlin Senate
- Secondary Level: Breakfast, lunch, afternoon snack, and all-day provision of fruit/vegetables and beverages (tea/water)
- Club activities, Use of the Makerspace, Creative materials, Additional support lessons where required

The following are not included in the school fees:

- Educational trips and excursions, Entrance fees, Personal consumable materials, Internal school events, Workbooks

School textbooks are provided on a loan basis.

### Fees

- Enrolment fee: € 375 per pupil, payable upon registration
- Reminder fee: € 2.50 for each payment reminder

### Discounts for New Contracts

- Loyalty discount: 25% per child if the child has attended a Klax institution for at least one year and subsequently enrolls directly at Klax International School.
- Sibling discount for multiple pupils at Klax International School (after deduction of any loyalty discount already granted):
  - o 1st sibling: 25%
  - o 2nd sibling: 50%
  - o 3rd sibling: 75%

## **Exemptions and Fee Reductions**

For a proven gross annual household income of up to € 29,429, the tuition fee is reduced to € 100 per month. In this case, the enrolment fee is waived.

In addition, the school provider allocates 10% of the total tuition revenue for full or partial fee remission for pupils in financial need.

An application for exemption from or reduction of school fees may be submitted to the school provider at any time. Decisions are made on a case-by-case basis upon proof of financial need. The application may be submitted at any time and will take effect from the first day of the month following submission. Fee exemption or reduction applies only for one school year or, if applied for after the start of the school year, until the end of that school year. A new application must be submitted for each school year. Only complete applications can be processed. ## **After-School Care (Hort)**

- After-school care or submission of an official after-school care voucher is mandatory for Years 1–4.
- Fees are determined by the official after-school care voucher, which must be submitted.

If no voucher has been submitted, privately funded after-school care will be charged at € 430 per month.

This Schedule of School Fees comes into effect on 1 April 2026.
